Milan, November 29, 2016 – Relating to the public tender offer (the “**Offer**”) promoted on all ordinary shares of Alerion Clean Power S.p.a. (the “**Alerion**”), Eolo Energia S.r.l. informs, pursuant to art. 41, paragraph 2 of Issuers Regulation, to have acquired out of the Offer No. 169,129 Alerion shares, equal to 0.388% of the share capital, at the same price of 2.46 euro, pursuant to art. 44, paragraph 8 of Issuers Regulation.

The settlement date is December 1, 2016.

Following these purchases and those communicated on November 18, 21, 22, 23, 24, 25 and 28, 2016, Eolo Energia S.r.l holds 5,461,279 Alerion shares, equal to 12.532% of the share capital.
